❖Reminders:

- 1. According to Article 2 of the regulations for transferring departments and the institute, the number of transferred students shall not exceed 20 percent of the initial approved number of students by the prospective department/institute.
- 2. According to Article 4 of the regulations for transferring departments and institutes, students must complete at least one semester before submitting the application form.
- 3. According to Article 6 of the regulations for transferring departments and the institute, students may only transfer once. The application cannot be changed or canceled once the application form is approved.
- 4. Transfer applications will be reviewed online only. Application is open from May 19th to June 13th, 2025. Please submit the application form and upload documents (PDF file only with a maximum of 2M) to the "Student Transfer Application System". Once submitted successfully, please consult with the applicant's class advisor by yourself, and the system will email the applicant's advisor to consult with the applicant.
- 5. The prospective department can check applicants' transcripts from the "Student Transfer Application System". Due to the Spring 2025 (113-2), teachers' online login results will be ending by June 27th, 2025; it is expected that the Registry Division of the Office of Academic Affairs will announce this semester's grades after June 30th, 2025.
- 6. All application forms will be reviewed online. After the initial department reviews the application form, the form will forward to the first-choice department/institute and college to review (Transcript not required: May 19th to July 7th, 2025; Transcript required: July 1st to July 7th, 2025). Once the first-choice department rejects the application, the form will deliver to the second-choice department/institute and college to review (July 8th to July 10th, 2025). The Registry Division of the Office of Academic Affairs will announce the result before July 25th, 2025.
