## Explanation:

1. Undergraduate students must pay full tuition and miscellaneous fees within the normal study period (four years, eight semesters). During an extended study period, if credits taken in a semester are between 0 and 4.5 (less than 5), 1/4 of the full tuition and miscellaneous fees are required; for 5 to 8.5 credits (less than 9), 1/2 of the full tuition and miscellaneous fees are required; for 9.0 credits or more, full tuition and miscellaneous fees are charged. Non-teacher training students taking courses offered by the Center for Teacher Education are also required to pay education program credit fees.
2. Students eligible for delayed graduation, during the extended study period, if they only take education program credit courses, and earn between 0 and 8.5 credits (less than 9), only education program credit fees are charged. However, if applying for university accommodation, priority is given to students who have paid tuition and miscellaneous fees. If credits earned are 9.0 or more, 1/2 of the full tuition and miscellaneous fees are charged, and education program credit fees are also required.
3. The abovementioned extended study period is based on the Ministry of Education regulations regarding the number of academic terms a student's enrollment exceeds the normal four years, eight semesters (starting from the ninth semester).
4. The tuition and miscellaneous fees are classified according to the nature of the student's department, not by the college to which they belong.
5. Undergraduate students who have already paid tuition and miscellaneous fees and take graduate courses do not need to pay additional credit fees.
6. External students taking elective courses and graduate students from this university taking undergraduate courses are charged a credit fee of NT\$ 1,100 per credit, following the secondary education program. However, based on the cooperation school inter-course selection and exchange cooperation agreement signed by this university and strategic alliance schools, undergraduate students (excluding those eligible for delayed graduation) are exempt from credit fees for cross-school elective courses based on reciprocal principles. Graduate students, summer sessions, education program courses, and undergraduate delayed graduation students are subject to credit fees according to each school's regulations.
7. The charging rules for music instruction fees for undergraduate programs are as follows:
  - (1) Students of the music department who enrolled from the academic year 2017 onwards, delayed graduation students and re-enrolled students, and students from other departments who choose to study technical music instruction courses are charged NT\$ 10,195 per credit for major studies, NT\$ 5,098 per 0.5 credit for minor studies, and NT\$ 590 for keyboard maintenance fee. (Approved by the 2<sup>nd</sup> administrative meeting of the 2<sup>nd</sup> semester of the academic year 2018)
  - (2) Students of the music department who enrolled before the academic year 2016, within the normal study period (eight semesters), are charged NT\$ 10,195 per semester for music instruction and NT\$ 590 for keyboard maintenance fee. (Approved by the 6<sup>th</sup> administrative meeting of the 2<sup>nd</sup> semester of the academic year 2015)

- (3) If students require additional individual music instruction courses due to personal needs (such as studying two major or minor technical courses simultaneously, personal interests, or summer courses), they must pay NT\$ 18,000 per credit for major studies and NT\$ 9,000 per 0.5 credit for minor studies.
8. Undergraduate students who spend an entire semester on full-time external internships without taking any credits at the University are charged full tuition and 4/5 miscellaneous fees within the normal study period (four years, eight semesters); during the extended study period, if credits earned are between 0 and 4.5 (less than 5), 1/4 of the miscellaneous fees are required; for 5 to 8.5 credits (less than 9), 1/2 of the miscellaneous fees are required; for 9.0 credits or more, full tuition and 4/5 miscellaneous fees are charged. (Approved by the 4<sup>th</sup> administrative meeting of the 1<sup>st</sup> semester of the academic year 2020)

Explanation:

1. Graduate students are required to pay the basic tuition and miscellaneous fees (until their graduation) and graduate credit fees each semester, calculated as follows: Basic tuition and miscellaneous fees + Credit fee \* Number of credits taken. If a student is only undertaking thesis supervision (0 credits), they still need to pay the full basic tuition and miscellaneous fees but are exempt from the credit fee.
2. Graduate students who have completed their required courses and thesis in their major field, and are only taking education program credit courses, need to pay only the credit fee if they earn less than 8.5 credits (less than 9) in a semester. However, if they apply for university accommodation, priority is given to students who have paid the full basic tuition and miscellaneous fees. If credits earned are 9.0 or more, they must pay the full basic tuition and miscellaneous fees plus the education program credit fee.
3. The basic tuition and miscellaneous fees and the credit fee are categorized according to the nature of the student's department, not by the college to which they belong.
4. Interdisciplinary course credit fees for graduate students are charged based on the standards set by the offering department.
5. Graduate students who are domestic nationals or overseas Chinese nationals taking undergraduate courses are charged NT\$ 1,100 per credit, following the secondary education program. International students and mainland Chinese students taking undergraduate courses are charged NT\$ 2,200 per credit.
6. The charging rules for music instruction fee master's programs are as follows:
  - (1) Master's students and re-enrolled students in the music department who enrolled from the academic year 2017 onwards are charged NT\$ 13,000 per credit for major studies, NT\$ 6,500 per 0.5 credit for minor studies, and NT\$ 590 for keyboard maintenance fee. (Approved by the 2<sup>nd</sup> administrative meeting of the 2<sup>nd</sup> semester of the academic year 2018)
  - (2) Master's students in the music department who enrolled before the academic year 2016 and

completed their studies within the prescribed period are charged NT\$ 9,000 per credit for major studies, NT\$ 4,500 per 0.5 credit for minor studies, and NT\$ 590 for keyboard maintenance fee.

(3) If students require additional individual music instruction courses due to personal needs (such as studying two major or minor technical courses simultaneously, personal interests, etc.), they must pay NT\$ 18,000 per credit for major studies and NT\$ 9,000 per 0.5 credit for minor studies.

7. Graduate students who spend an entire semester on full-time external internships without taking any credits at the University are charged 3/5 of the basic tuition and miscellaneous fees and full credit fee within the normal study period (four years, eight semesters). (Approved by the 4<sup>th</sup> administrative meeting of the 1<sup>st</sup> semester of the academic year 2020)

V. The charging standards for non-degree students selecting courses in secondary education programs are NT\$ 1,100 per credit. For those selecting primary education programs, the fee is NT\$ 1,140 per credit. The charging standards for credits in summer courses are determined by each offering unit, referencing the University's charging standards for various educational programs and specialized classes (see the "Appendix" for charging standards for summer courses), and are managed according to the University's *Implementation Measures for Summer Class Opening and Teaching* and the *Financial Management Guidelines for Summer Funds*.

VI. Students who are granted approved leave of absence before the registration date (inclusive) are exempt from payment. Freshmen and transfer students with a lottery system who apply for withdrawal before the University's admission and lottery deadline are eligible for a full refund.

3. For those studying individual music instruction courses during the summer session offered by the Music Department, the fee is NT\$ 18,000 per credit for major studies and NT\$ 9,000 per 0.5 credit for minor studies.
